

District has verified that the application for provisional recognition with reference to the Inspection report of the Inspecting Officer and also with reference to the conditions laid down in the permission orders G.O. Ms.No.1/Edn.Dt.1-1-94 and submitted a report in his Ir.No. 393/SNR/94

After careful examination of the cited reference conditions prescribed in G.O. Ms.No.1/Edn.Dt.1-1-94. The Committee Authority hereby accords provisional recognition to classes I to V (EM) ~~1123/24/94~~ for period of 5 years commencing from the academic year i.e. 1993-94 to 1997-98 in respect of Little Scholar School, Chikoti Garden, Begumpet, Hyd.

1. that the society shall abide by the instructions/rules regulations made by the Government or Authorised officers from time to time.
2. that the educational institution shall serve the needs of the locality more particularly.
3. that the institutions shall adopt the curriculam and syllabus prescribed from time to time.
4. the school timings vacations and mid-term holidays shall be as prescribed by Govt. from time to time.
5. that the qualified staff within the age limits prescribed by the Govt. for Govt. Employer shall be appointed as per staff pattern.
6. that the results of the institutions shall be satisfactory every year.
7. that the records/accounts shall be furnished to the DEO every year by 31st August at the latest.
8. that the list of governing body shall be furnished to the DEO every year.
9. that the pay structure/fee structure fixed by the Governing body shall be got approved by the DEO every year.
10. that all the conditions prescribed in the GOs and other orders which are not specified in this orders shall be complied with.
11. that the school shall not be closed without giving notice both to the parents/DEO and competent authority atleast 6 months before.
12. that the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.
13. that the society shall submit proposals for renewal of provisional recognition sufficiently in advance i.e. atleast 6 months prior to the date of expiry of the renewal.
14. S.R. should be opened.
